1. Usage Purpose

- May only be used indoor.
- The Fire Alarm Sounders must be placed according to the Fire Evacuation Plan and such to be heard from any possible points in order to operate compliant with their purpose.
- The selection of the mounting locations and commissioning should be performed with the technical service.
- The product doesn't need any further activations after being powered.
- 2 x 1,5 mm cables should be used.





3. Mounting Instructions

- 1- Perforate the cable hole (point a) of the lower casing (Figure 1) and insert the sounder cables here.
- 2- Place the washer at locations, where IP 44 needs to be used (Figure 2).
- 3- Perform the wall mounting according to the dimension of the wall mounting points.
- 4- Perform the connection between the connector in the upper casing (Figure 2(a)) with the connector indicated on Page 2.
- 5- Place the upper casing (Figure 2(a)) according to the notches to be seen in the figure on the lower casing (Figure 2(b)).
- 6- Turn the casing counter clock wise.
- 7- Fix the plastic metric 2,5 x 6,5 mm screw in the box into the screw hole in the lower casing.







4. Warnings

Be sure that the sounder line connections are correct.

Perform the periodical maintenances.

Call the authorized service for the annual control.

Avoid contact with water, dust and chemical materials.

Don't touch with wet hands.

The plastic protection must remain on until it is ready for use.

The product warranty term is 2 (two) years.


The product usage life term determined by the ministry is 5 years.

WARRANTY CERTIFICATE

- 1. The warranty term starts as of the date of the delivery and is 2 (two) years.
- 2. The whole product, including all parts, is within the scope of the warranty of our company.
- 3. The duration spent for repair is added to the warranty term in case of a defect of the product during the warranty term. The repair term of the product is maximal 30 (thirty) working days. This term starts as of the delivery date of the product to the service station, and in case of an absence of a service station, as of the notification to the seller, distributor, agency, representation, importer or manufacturer of the product, respectively.
- 4. In case of a defect of the product during the warranty term due to both material and workmanship and assembly, it shall be repaired without requesting any costs for workmanship, the changed part(s) or under any other title.
- 5. The product will be replaced charge-free, when
 - the same defect should be repeated more than 2 times within 1 year or when the product shouldn't be able to be used permanently due to more than 4 different defects, provided to be within the term of the warranty,
 - the max. repair term should be exceeded
 - in case of the absence of a service, it should be determined in the report to be established by the seller, distributor, agency, representation, importer or manufacturer of the product, respectively, that the product is not able to be repaired.
- 6. Defects due to usage of the product contrary to the issues indicated in the user's guide are excluded from the scope of the warranty.
- 7. The Ministry for Industry and Trade, General Directorate for the Preservation of Consumers and Competition can be referred to in case of disputes arising out of the warranty certificate.
